For example, political instability, armed conflict, and climate change are some of the leading reasons why people are forced to leave their home countries. Security checks at airports are an essential part of international travel, aimed at ensuring the safety of passengers and preventing criminal activity. These security procedures can take a considerable amount of time, with passengers typically spending 2-3 hours on average before their flights (International Air Transport Association, 2021). This lengthy process includes screening for prohibited items, ensuring the safety of luggage, and verifying the identities of travelers. Although necessary, these measures have also led to frustration among passengers who experience delays and increased waiting times. Customs inspections play a crucial role in safeguarding national borders. In 2023, over 70 million international travelers underwent customs inspections in the United States (U.S. Customs and Border Protection data). Customs officers are responsible for ensuring that illegal goods, such as drugs or counterfeit products, do not enter the country. Additionally, they monitor the importation of agricultural goods to prevent the spread of diseases or pests that could affect local industries. With the rise in global trade and travel, the complexity of customs procedures has grown, requiring more sophisticated technologies and trained personnel. Moreover, immigration policies vary significantly from country to country. For instance, while some countries have strict border controls and limited refugee intake, others have more open immigration policies aimed at attracting skilled workers or addressing labor shortages. This disparity has led to debates about





immigration reform, with some advocating for stricter measures to protect national security, while others emphasize the economic benefits that immigrants bring to host countries. These delays create uncertainty for immigrants, as well as difficulties in meeting labor market demands in host countries. Airport security and customs procedures are also increasingly relying on technology to streamline operations. In recent years, biometric systems, such as facial recognition and fingerprint scanning, have been implemented to speed up identity verification and reduce the need for manual checks. For example, biometric screening at airports has been shown to cut the time spent at checkpoints by up to 30%, improving the overall travel experience (International Civil Aviation Organization, 2021). However, concerns over privacy and data security continue to arise, with critics arguing that biometric data could be misused or hacked. Another issue linked to immigration is the rise of undocumented immigration, where people enter a country without proper authorization. This issue is particularly prominent in the United States, where it is estimated that 10.5 million undocumented immigrants were living in the country in 2020 (Pew Research Center). While some argue that undocumented immigrants contribute significantly to the economy, especially in industries such as agriculture and construction, others raise concerns about the strain they may place on social services and public resources. Furthermore, customs inspections can also cause economic disruptions, particularly in the global supply chain. The COVID-19 pandemic exposed vulnerabilities in international trade, as border closures and increased customs checks led to delays in the movement of goods. For example, in 2020, global trade volumes fell by 5.3% due to disruptions in customs procedures and travel restrictions (World Trade Organization). These disruptions not only affected businesses but also led to shortages of essential goods such as medical supplies and food products in certain regions. This part addresses additional challenges related to immigration, security, and customs, while also touching on technological advancements and economic implications.





Additionally, researchers from Tashkent Chemical International University, Nargiza Akhamovna and Feruzbek Inomjonov, focus on the role of "Tourism Police" in ensuring tourist safety.
